PAR participates in Valor Day, holds bankruptcy CLE, and prepares for golf fundraiser

The Paralegal Association of Rochester, Inc. (PAR) participated in Valor Day that was held at the Brighton Campus at Monroe Community College on June 18. Valor Day is a free event for all veterans, active duty or reserve service members and immediate family.

It is a one-stop shop for veterans to receive one-on-one legal con-

sultations with attorneys from numerous legal fields, employment and counseling workshops, credit/financial counseling, GI Bill benefits counseling, access to service providers, local businesses, and universities.

Members of PAR greeted over 75 veterans and family members, assisted with registration, and guided veterans to the legal area and other areas throughout the event. We were honored to be a part of Valor Day and being able to give back to our veterans.

On July 13, PAR held an Overview of the Bankruptcy Practice seminar presented by Christopher K. Werner, Esq. and C. Bruce Lawrence, Esq. of Boylan Code LLP. Mr. Werner started off the seminar. He is an attorney that represents debtors. He discussed the differences between Chapter 7 and Chapter 13, Schedules, Statement of Financial Affairs, Means Test, Automatic Stay, what to expect at the Trustee's meeting, Preferential Payments, avoidance of Judgment liens (522f), and avoidance of unsecured mortgages (Pond Motions).

A debtor must go to Consumer Credit Counseling and receive a pre-bankruptcy

certificate before filing for bankruptcy. He stressed that a debtor must disclose *all* assets when filing – even a piece of jewelry, such as a diamond ring.

Debtors are allowed New York State or Federal Exemptions for homestead, auto, household items, jewelry, and tools of the trade, to name a few. These exemptions must be listed with the Trustee in order for the debtor to receive them.

Mr. Lawrence is a former Bankruptcy Trustee, having served on the panel for 20 years. Mr. Lawrence discussed the Trustee's perspective. Currently, there are five Trustees for Chapter 7 and one for Chapter 13 in the Rochester Division of the Western District.

The Trustees are part of the Department of Justice and report to the Office of U.S. Trustee. The Trustees are responsible for administering assets of the individual case, and have to stay neutral and not give legal advice.

They review the Schedules and documents, which exemptions Federal or State have been selected (Trustees cannot point

out exemptions if the debtor does not list them), assets, real estate values, assessment, appraisal, review Kelly Blue Book Private Party Sale values, consider how estate assets can be liquidated at what cost/profit, check Means Test for accuracy, look for preferences and fraudulent conveyances (may do Google research, Facebook), and follow-up on creditor calls about assets.

Both the Debtor and Debtor's attorney should be present at the hearing. At the hearing the Trustee will look at the debtor's demeanor/attitude and attorneys that are trying to answer all of the questions that are asked by the Trustee. Trustees expect the attorneys to provide completed schedules and be prepared.

Both attorneys were excellent presenters and very informative. We hope to have them speak again in the future. Our next seminar will be on the topic "Legal Profession: Where We Are and Where

We Are Headed" presented by Timothy Hoover, Esq. from Hodgson Russ LLP on Aug. 23 at noon at the Powers Building. Registration forms will be emailed soon to our members. Be sure to check PAR's website for future events and flyers/registration forms.
